

Trouble Shooting



Case 1: The supplier asked for a 25% price increase on the pretext of rising raw material costs. Through negotiation, we finally set the price increase at 10% of the cost of raw materials, helping customers reduce costs by 15%.





Trouble Shooting

Case 2: After several rounds of qualified random inspections, the product still had quality problems at the terminal. In the case that the supplier denied the problem, we helped the customer to complete the claim of 80,000 US dollars.

Case 3: The supplier notified that the delivery date was delayed, and the customer faced the risk of not being able to catch up with the promotional season and canceling the \$160,000 order by the customer's client. We solved the problem by optimizing the








